



Fiscal Year 2023 Defense Spending by State Report Contract Spending






Fiscal Year 2023 Defense Spending by State Report Personnel Spending

Fiscal Year 2024 Activity

- Obligated a total of \$477M, matched by \$112M (\$589M total, 19% match)
 - ✓ 30 Installation Resilience Projects: \$22M Fed
 - ✓ 14 DCIP Projects: \$99.7M Fed
 - ✓ 9 PSMI Projects: \$331M
 - ✓ 7 Realignment Projects: \$8.2M
 - ✓ 12 Miscellaneous Projects: \$16M

Fiscal Year 2025 Congressional Update

National Defense Authorization Act

Senate Armed Services Committee Passed Bill

- Sec 2805 Adds modernization authority
- Sec 2846 Require update to PSMI assessment and priority list (2018 last time updated)
- Sec 2851 Requires annual progress briefing on the Defense Community Infrastructure program for three years
- Sec 2856 Adds Coast Guard eligibility to Defense Community Infrastructure Program

House Passed Bill

- Sec 2803 Adds modernization authority
- Sec 2803 Adds Coast Guard eligibility for military installation reviews grants

Defense Appropriations Act

<u>President's Budget Request</u> - \$180 for programs, to include \$50M for the Defense Community Infrastructure Program

House Passed Bill

• Funds at President's Budget Request

Senate Appropriations Passed Bill

• Adds \$60M to the Defense Community Infrastructure Program

Installation Resilience

- Seeking expanded definition of installation resilience move past climate-related threats
- Planning and design for improvements to respond to vulnerabilities
- Demand signal is still not clear, likely underrepresented
- Need to have full "in" by installations and utility companies
- Nexus for "partnering" effort IGSAs, etc.





Defense Community Infrastructure Program

- Need to start writing proposals now
- Host several listening sessions for feedback on proposal requirements – for military as well
 - ✓ Process
 - ✓ Match
 - ✓Military Value
 - ✓ Obstacles for submission
 - ✓ Ease of Process
- Expect 3rd party cost validation to be removed
- Revision to 12-month construction start date demonstrate viability of project





Modernization

- Seeking new authority to fund state and local modernization efforts that support the defense industrial base and/or our installations
- Targets of opportunity: shipyards, depots, legacy processes and facilities
- If industry and/or installation can recruit their military and civilian personnel/workforce needs can states and communities help to retain them????
 - Workforce, hard and soft infrastructure (schools, housing, roads, health care), transportation
- Sentinel Program , Shipbuilding, Depots





Community Noise Mitigation Program

- \$75 million program to reduce the impact of fixed wing military aviation noise on "covered" facilities near certain military installations
 - \$56.25 million active military installations
 - \$18.75 million reserve component installations
 - \$5 million communities near military installations that have transitioned to a new type of aircraft after January 1, 2019
- Currently reviewing proposals awards this winter
- Likely to compete any funds remaining in Spring 2025


Installation Resilience

- Partner to look beyond the obvious you truly don't know what you don't know
- Understand public infrastructure (transportation, utilities, cyber) and services (income-based housing, medical, education, child care) in context of installation and mission
- Metrics think about who is being affected (entire community population)
- Tabletop exercise gauge hard + soft infrastructure needs with stakeholders



Public Schools on Military Installations

- No invites for schools in Fiscal Year 2024 due to lack of appropriations
- Actively working proposals from schools through #71 from the Secretary's priority list
- To date, program has received \$3.25B in funding from Congress
 - \$1.3B obligated across 34 schools
 - \$1.87B available allocated for 32 school proposals
 - Encouraging Net-Zero designs







Defense Community Infrastructure Program

- Competitive program that addresses deficiencies in community infrastructure outside the fence line or on leased land that is supportive of a military installation, in order to:
 - enhance military value; support cadet training at covered educational facilities; installation resilience, and/or support military family quality of life
- \$100M for Fiscal Year 2024, 14 proposals invited
 - Between FY 2020 and FY 2023, awarded 65 projects representing \$300 million in Federal funding, \$251.7 in non-federal funding, and \$551.7 million in total project cost
- Eligibility: owned by a state or local government Not-for-profit member-owned utility service eligible as sub-recipient
- Adhere to NEPA requirements
- Importance of Installation Commander's Letter of Support
- \$250K minimum and up to \$20M maximum project
- 30% non-federal match
 - rural location waiver if project location population is under 100K
